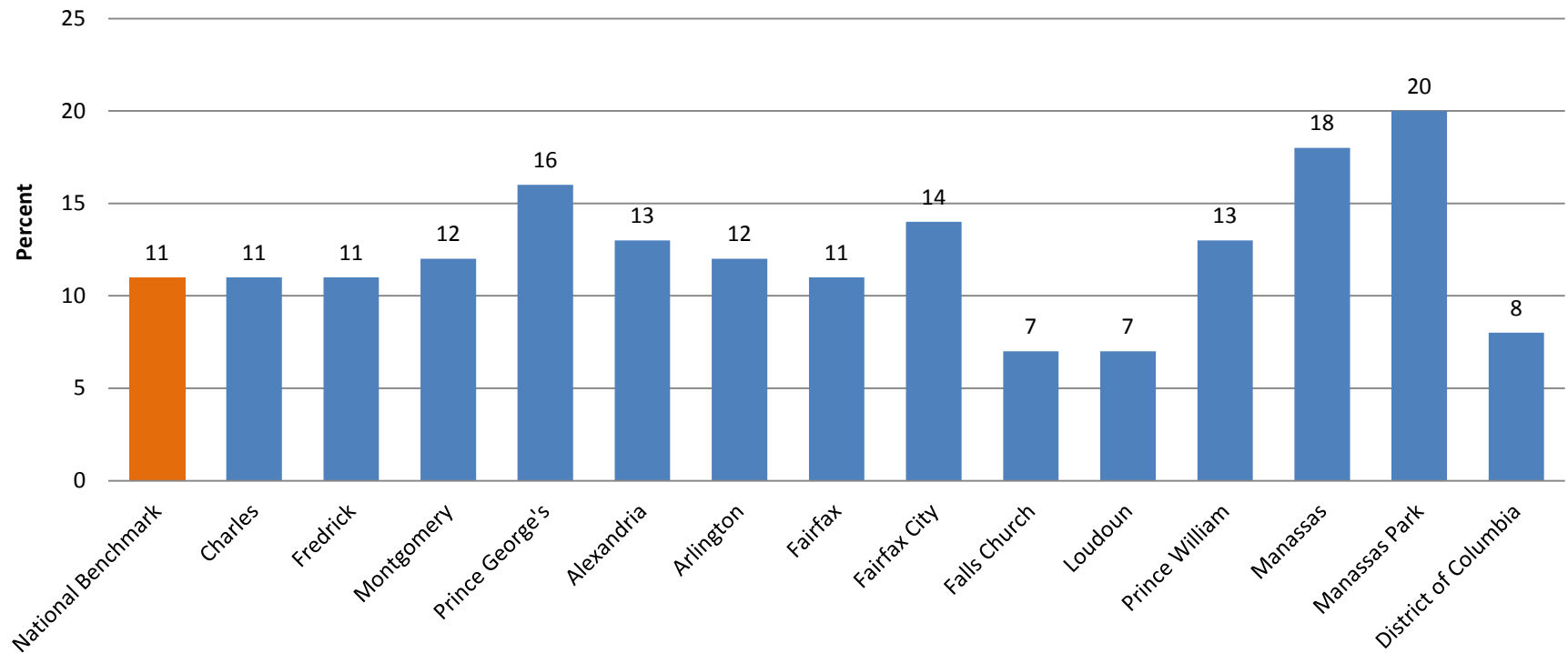

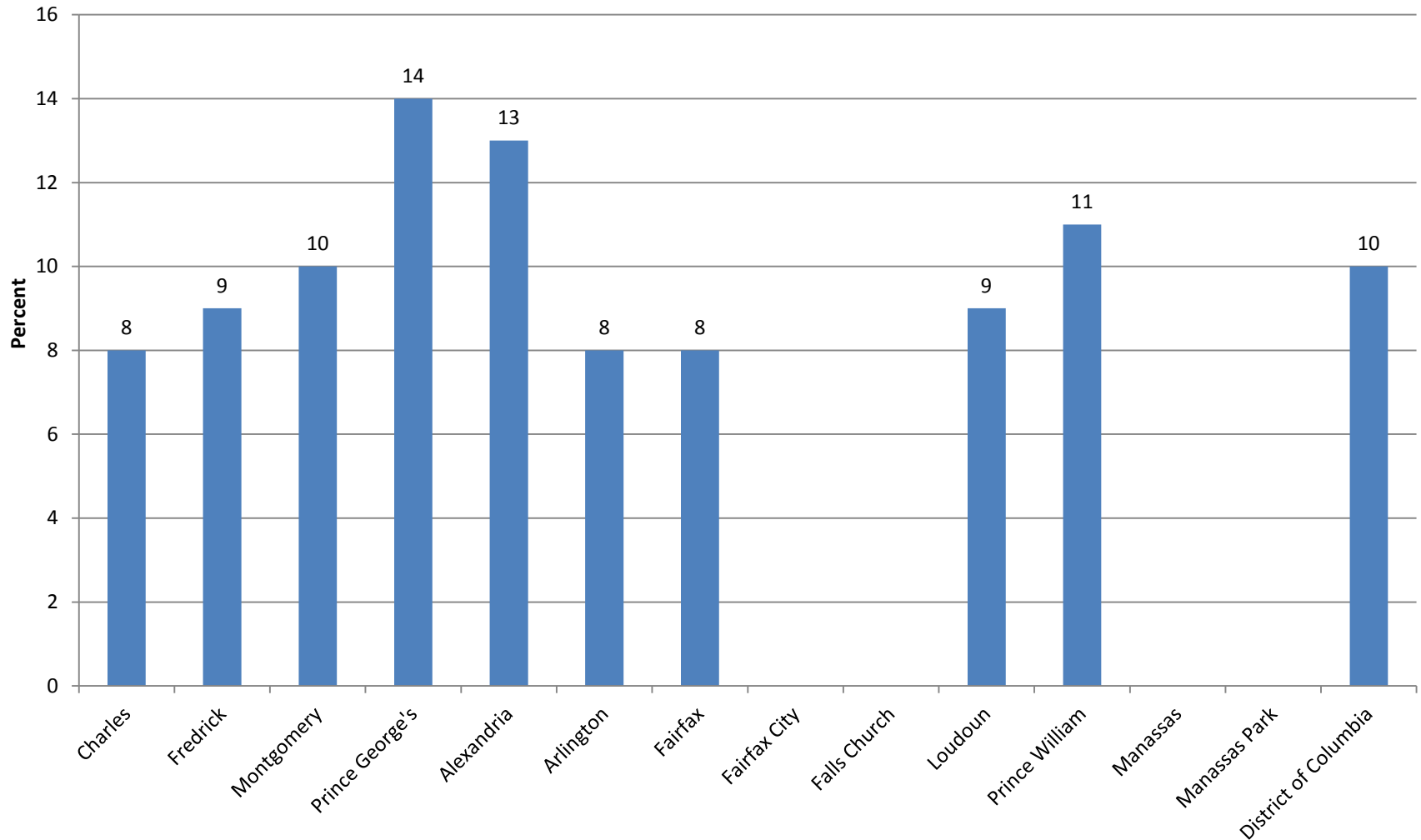
Uninsured Adults*

Could Not See Doctor Due to Cost*



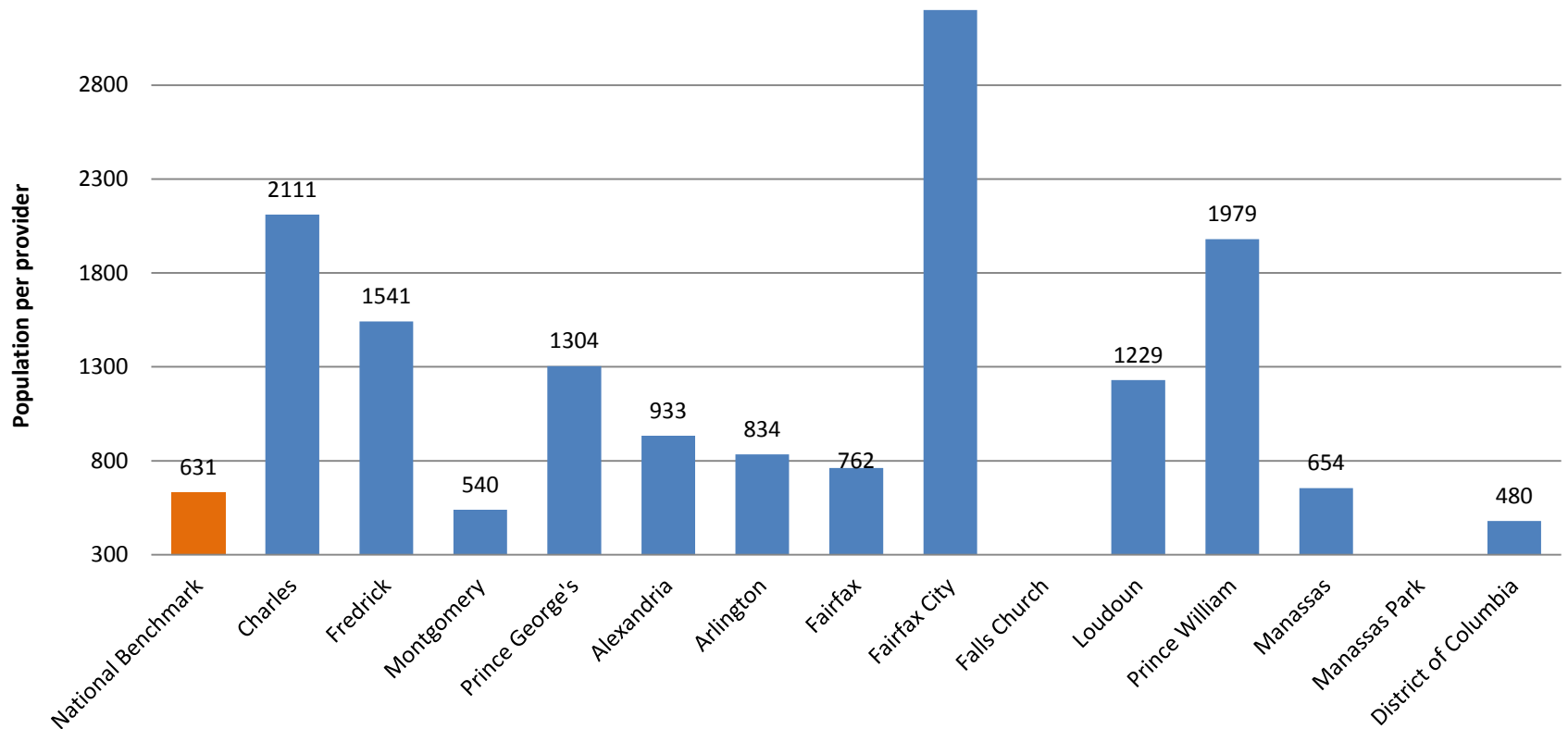

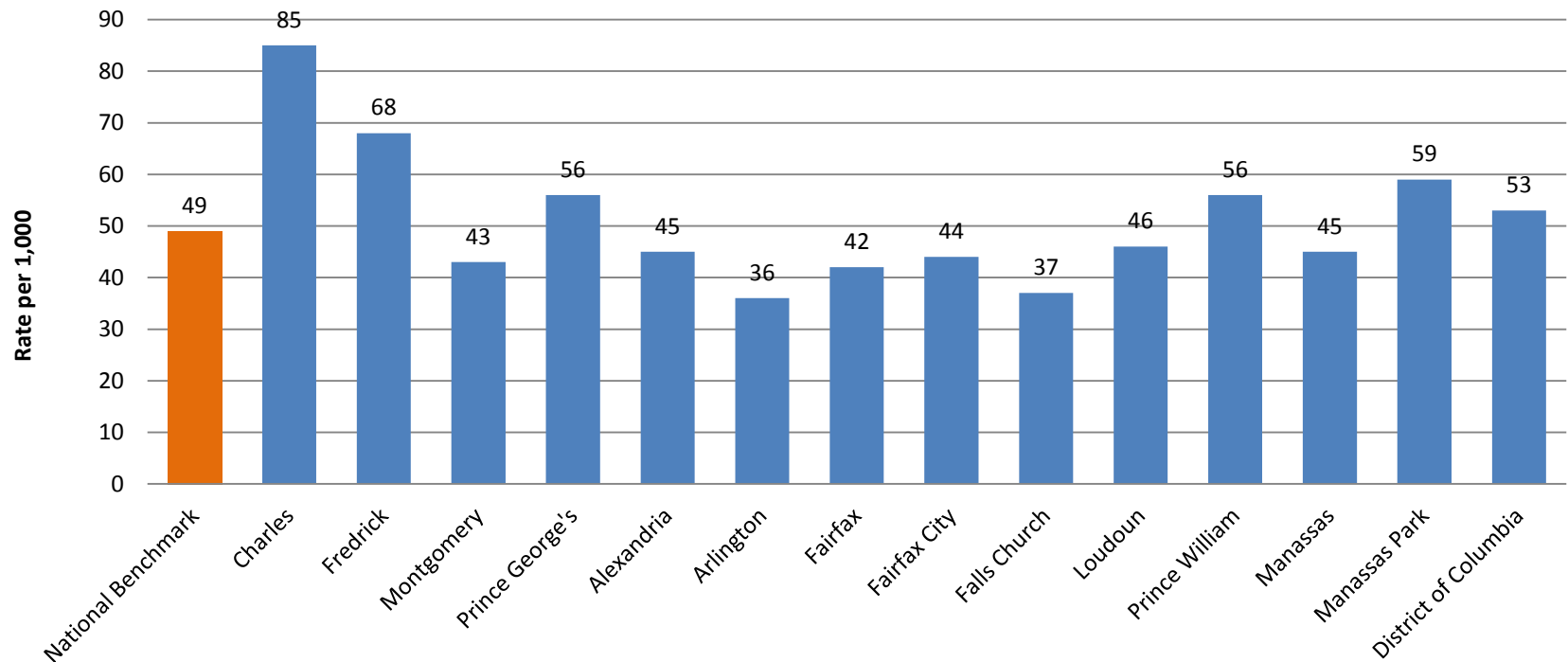
Primary Care Physicians*

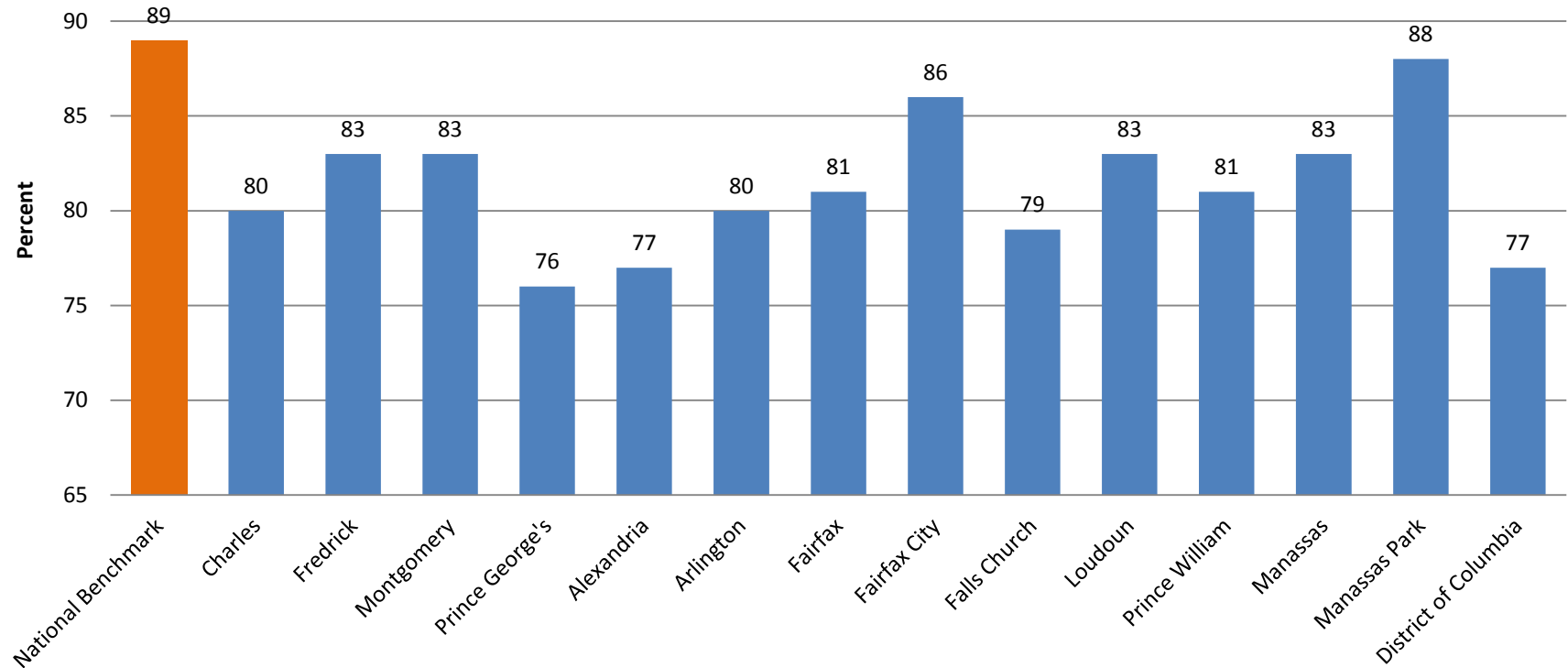
Preventable Hospital Stays*

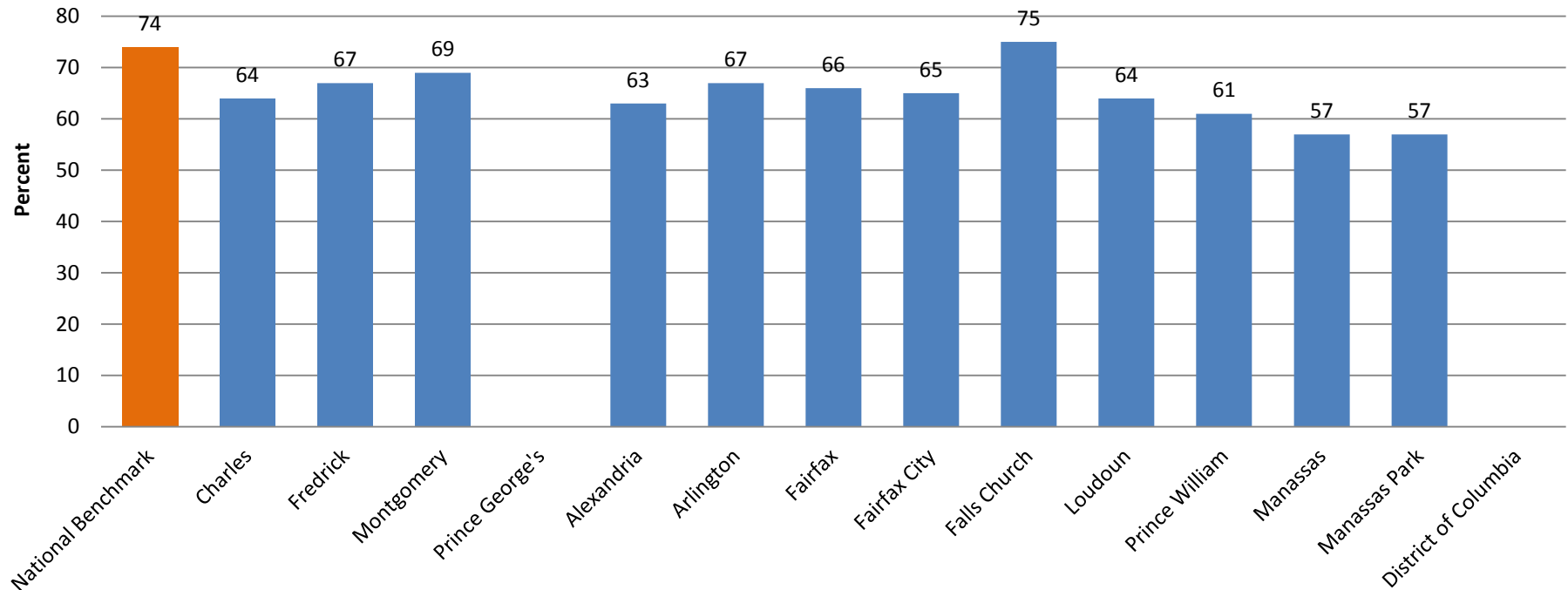
Diabetic Screening*

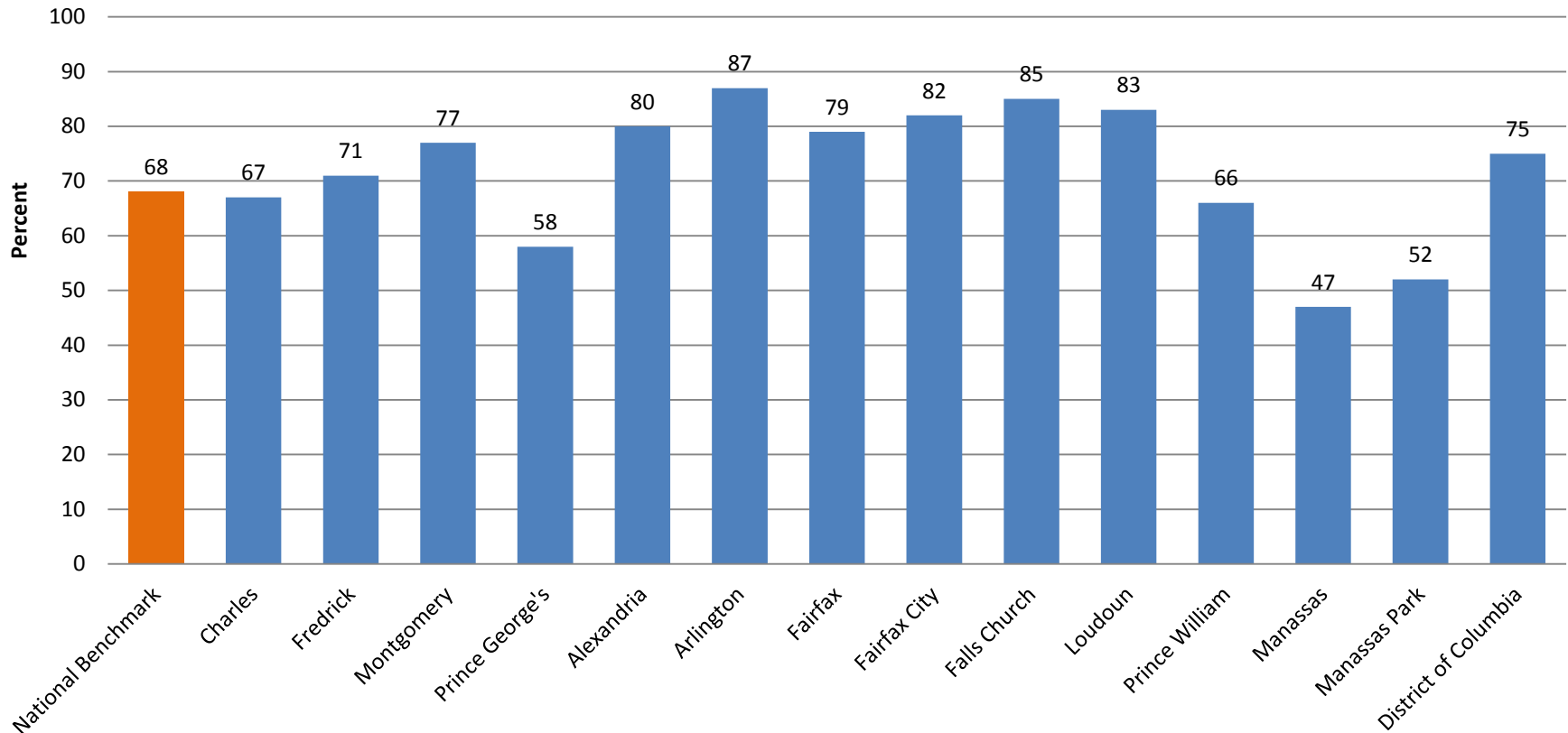
Mammography Screening*

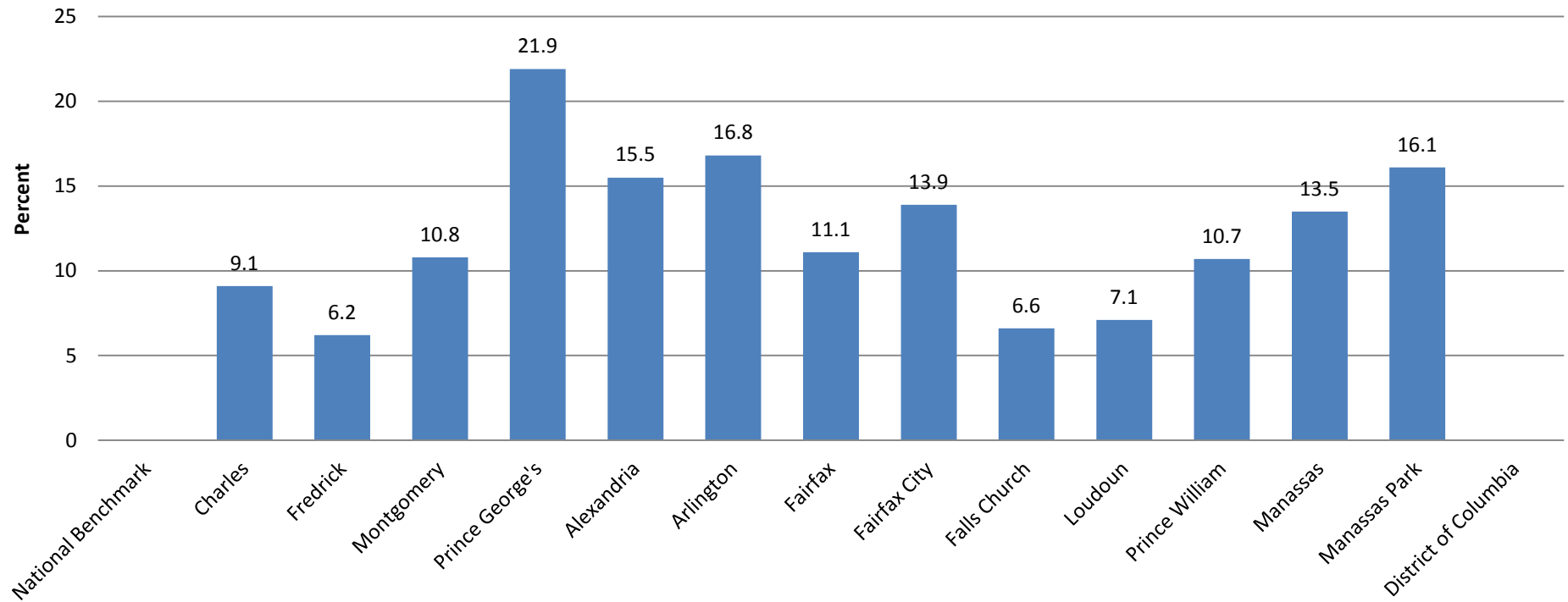
Some College*

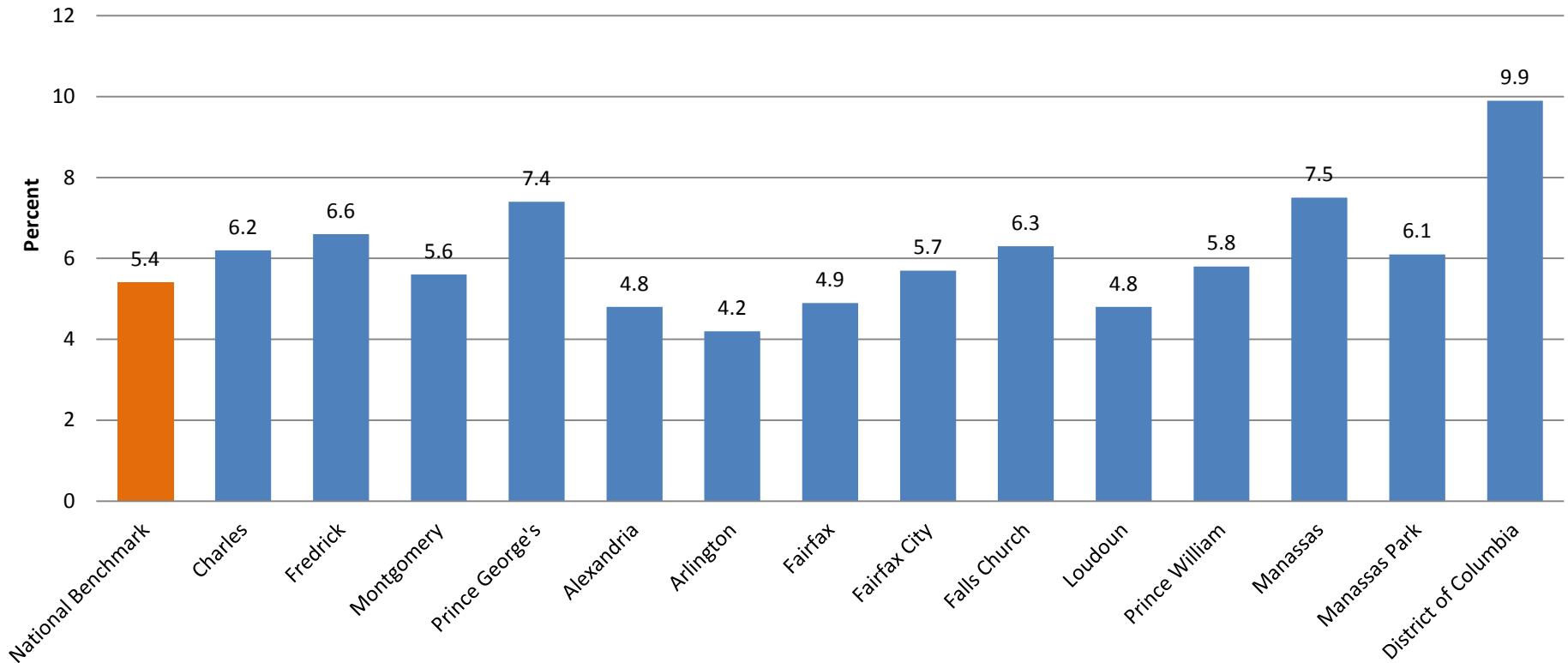
Illiteracy*

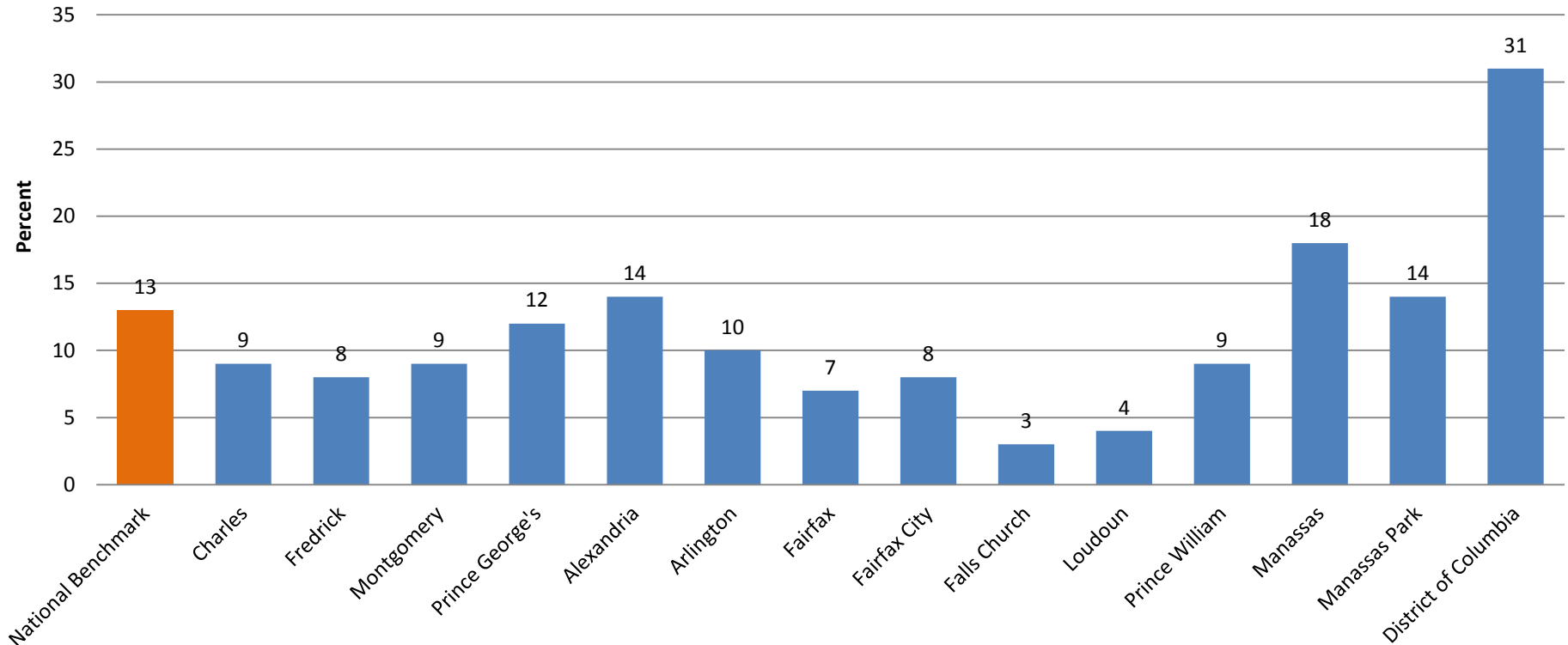
Unemployment*

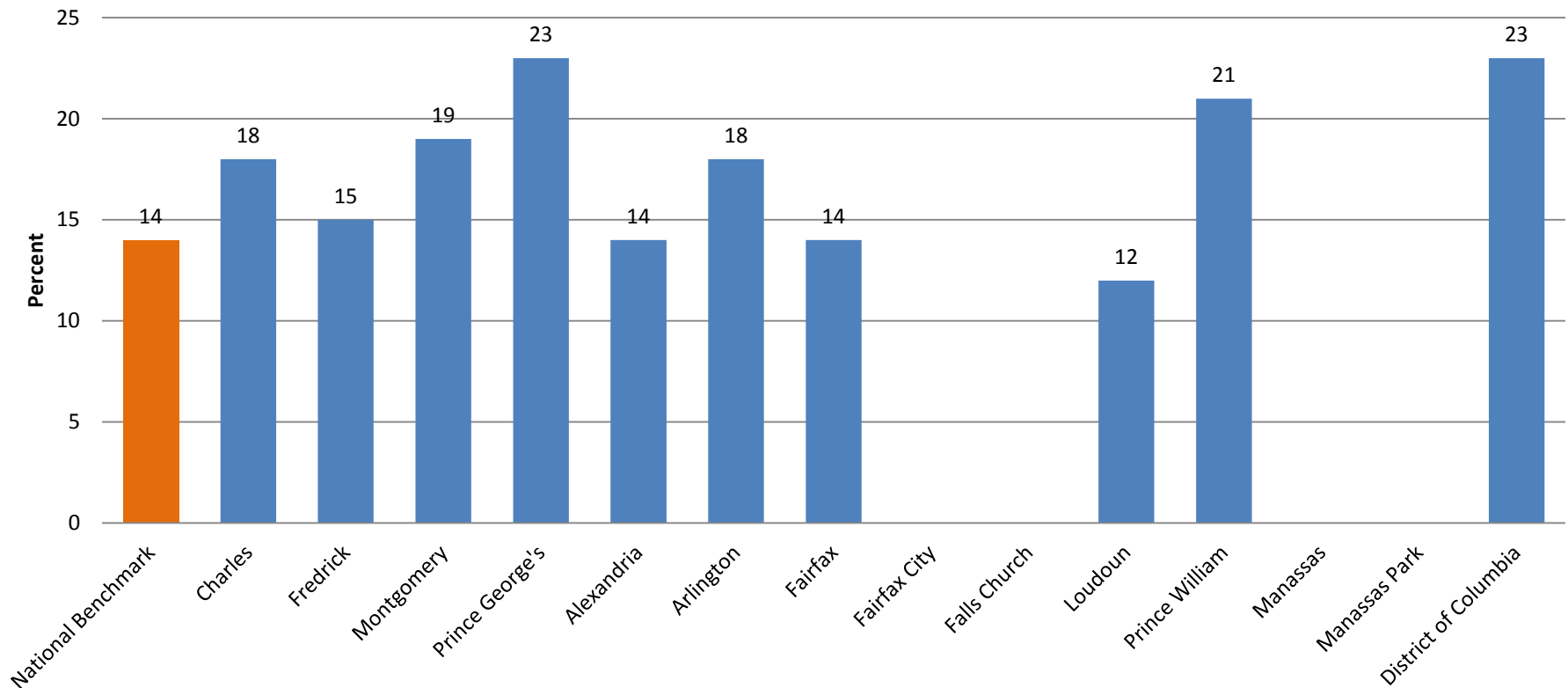
Children in Poverty*

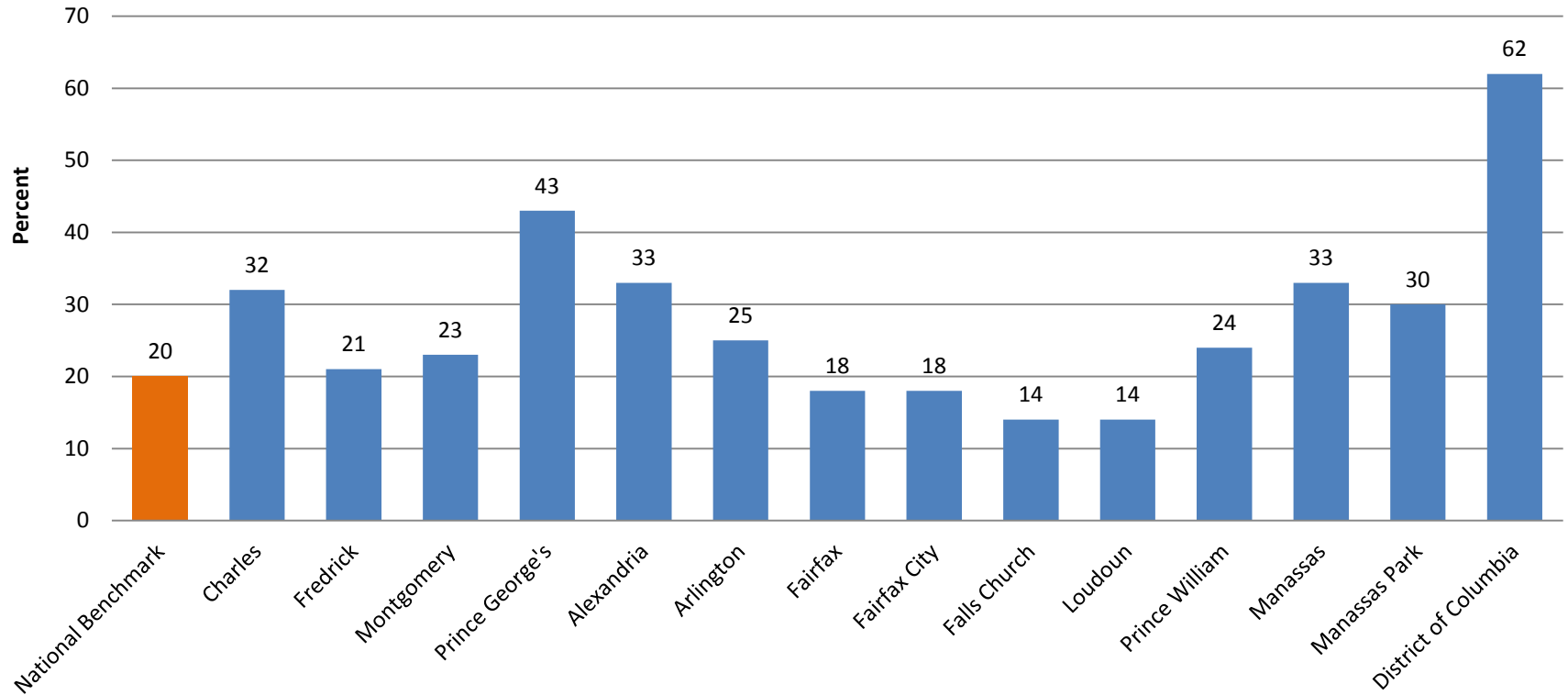
Inadequate Social Support*

County Health Rankings 2012, calculated by the National Center for Health Statistics using data obtained from the Centers for Disease Control and Prevention's Behavioral Risk Factor Surveillance System (BRFSS) 2006-2010. National Benchmark is set at 90th percentile.



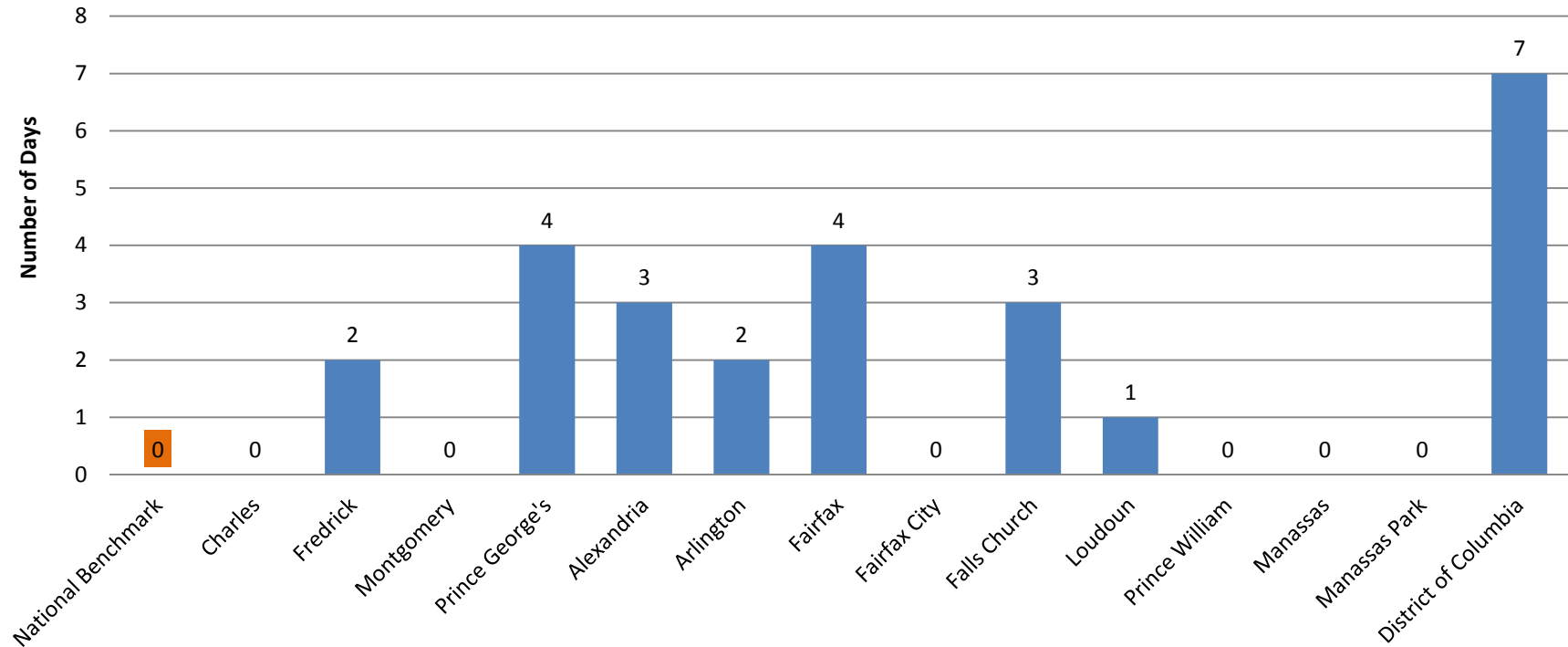
Children in Single Parent Household*



*Percent of children that live in household headed by a single parent. County Health Rankings 2012, using data from American Community Survey (ACS) 2006-2010. National Benchmark is set at 90th percentile.



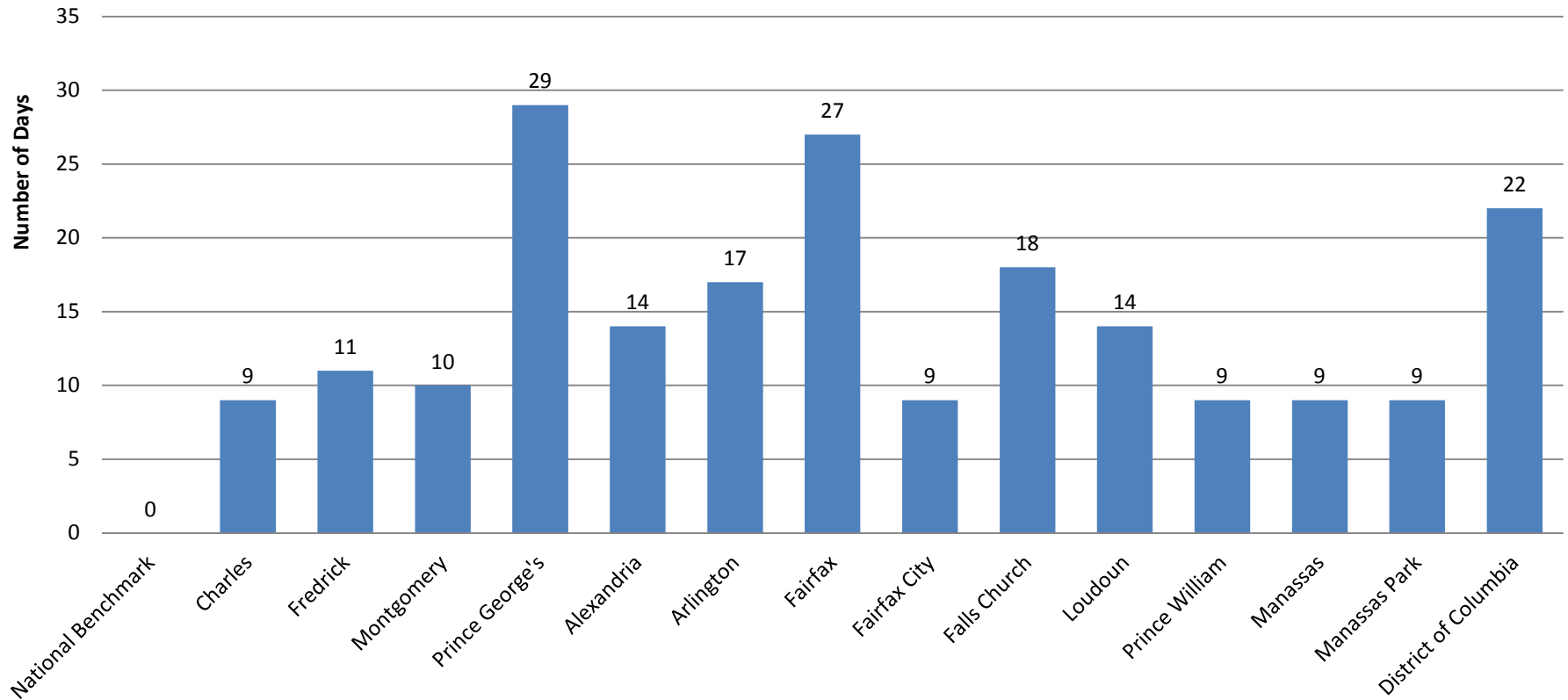
Air Pollution-Particulate Matter Days*



*Annual number of unhealthy air quality days due to fine particulate matter. County Health Rankings 2012, using data from the Public Health Air Surveillance Evaluation (PHASE) project . National Benchmark is set at 90th percentile.

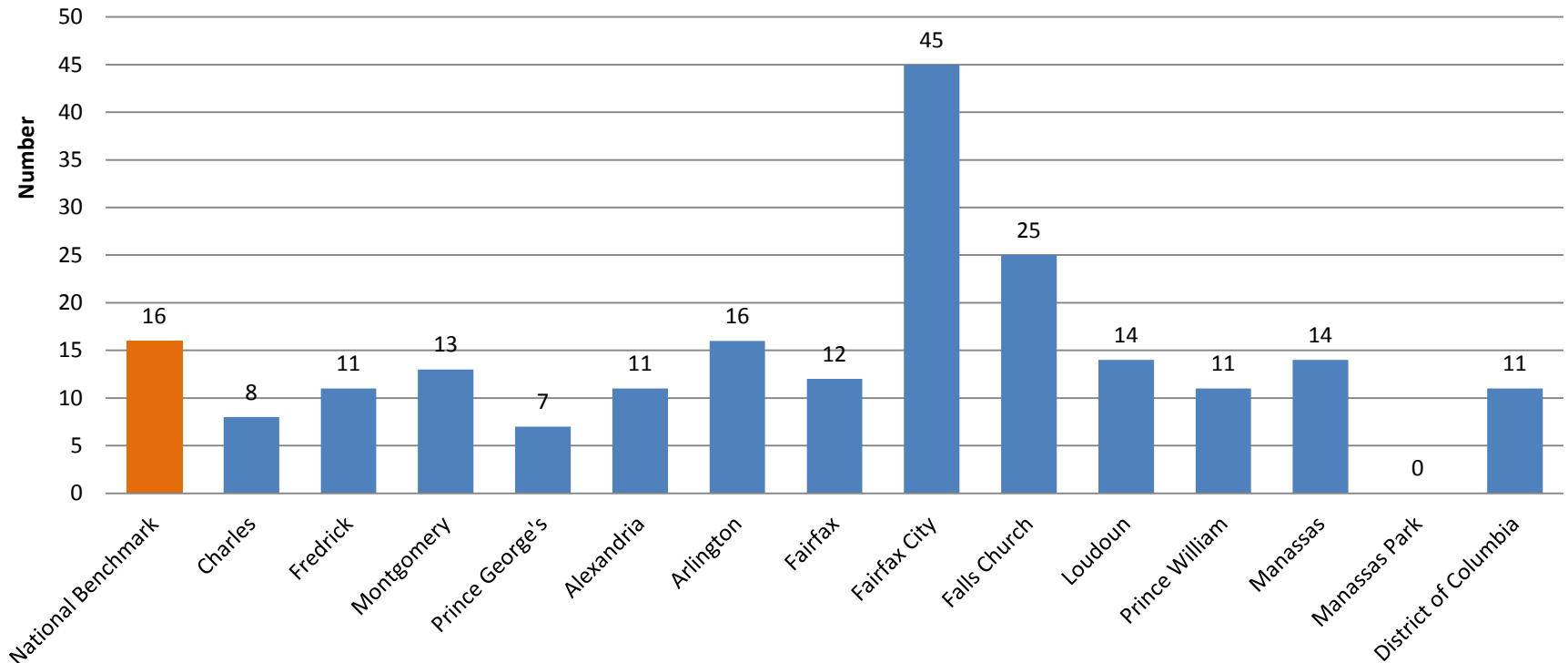


Air Pollution-Ozone Days*

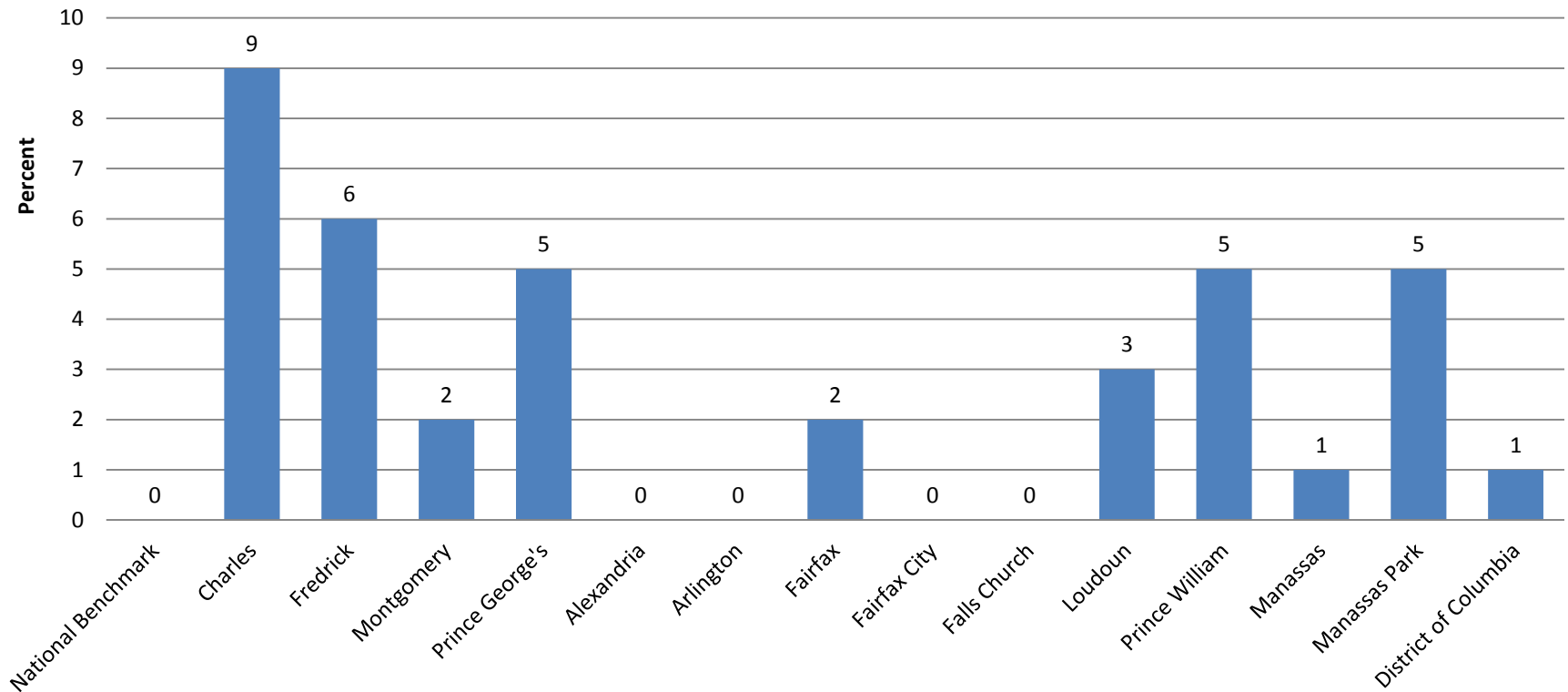
Access to Recreational Facilities*

County Health Rankings 2012, based on a measure from United States Department of Agriculture (USDA) Food Environment Atlas and calculated using the most current County Business Patterns data set. Recreational facilities are identified by North American Industrial Classification System (NAICS) code 713940 2009. National Benchmark is set at 90th percentile.



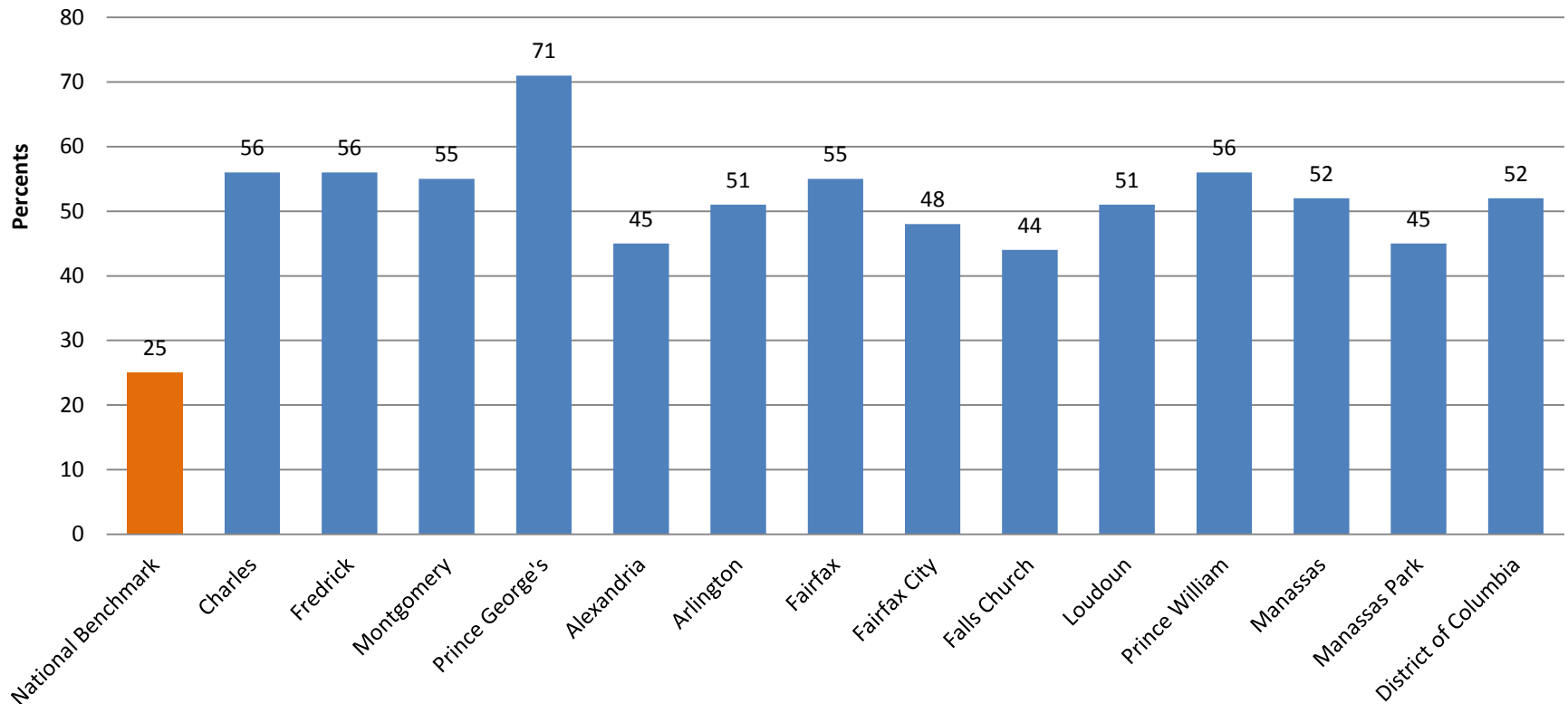
Limited Access to Healthy Foods*
